### Rules and Regulations

Individuals who have purchased an annual pass with good standing have the full use of Club facilities at any time during business hours. Range balls must be purchased to use the range. You may reserve starting times up to two weeks in advance for weekday/weekend and holiday play. If you decide to ride in a golf cart during play, you must pay a \$10.00 cart fee for nine holes or \$15.00 cart fee for eighteen holes. Guests will pay the applicable rate for the time of play.

**PLEASE NOTE: Starting July 1, 2024 Annual Pass Holders will be prohibited from reserving tee times before 11am on Weekends and Holidays. Regular rates will be applied prior to 11am. Clustered Spires Association Tournaments will be the exception.**

Eligibility Requirements: Individuals 18 and over who have signed an application and paid in full.

Current rates: \$2000.00 Individuals with proof of residency in Frederick City will be charged \$1500.00. Valid for one (1) year (12 months) from date of purchase. Rates are subject to change each year.

Individuals who have purchased an annual pass must abide by all Clustered Spires Golf Club's rules and regulations, including but not limited to:

- Dress Code – Proper golf clothing is required.
- Damages – Any damage to the golf club property by the individual who purchased the annual pass shall be the responsibility of that individual.
- Registration – You must check in to the golf shop prior to use of the facilities. The Annual pass id card must be presented at that time. Annual pass cards and the benefits are to be limited solely to the individual who is registered.
- Restrictions – Patrons are not allowed in cart barn or behind Pro Shop counter, for safety and liability reasons.
